RELEASE AND INDEMNITY AGREEMENT

This release and indemnity agreement ("Release") is made by the undersigned adult ("Participant"), to release and indemnify the property owners of **Martyn Meadows Ranch** 32320 RCR 20, Steamboat Springs, Co. 80487, Charles and Penny Martyn, and their respective employees, agents, contractors, heirs, successors, representatives, insurers, and any other person related to the ownership or management of Martyn Meadows Ranch from liability for any injuries sustained by me, or by my employees, heirs, representatives, dependents, or guests (my "Associates"), in consideration of the use of the property or facilities of Martyn Meadows Ranch. I, the Participant, recognize that all recreational activities at Martyn Meadows Ranch, including, but not limited to, horseback riding, team roping, snow shoeing, cross-country skiing, fishing, boating, hiking and biking are inherently dangerous, that accidents are frequent, that the condition of the land is often rugged and hazardous, the arena footing is uneven, and that a horse may act or react unpredictably. I understand and acknowledge that wearing a helmet or other protective headgear may decrease the possibility or severity of potential injuries. In light of this knowledge, I, the Participant, voluntarily participate in the activities, and I assume the risks and undertake full responsibility for any injury to me, to my stock or to my Associates, and for any property damages that may occur.

By signing this Release, I, the Participant, acknowledge my own responsibility to have in force adequate medical and liability insurance, and I acknowledge that the owners of Martyn Meadows Ranch and Parties will assume no responsibility for me.

With full knowledge, I, the Participant, release the Martyn Meadows Ranch Parties from any and all liability for any personal injury, death or property damage occurring in connection with the use of the property or facilities of Martyn Meadows Ranch. It is agreed that I and my Associates shall have no right or action against the Martyn Meadows Ranch Parties, and I agree not to sue any of the Martyn Meadows Ranch Parties, with respect to any cause of action for personal injury, property damage, illnesses or death occurring as a result of the activity. I, the Participant, agree to indemnify and hold harmless the Martyn Meadows Ranch parties from and against all claims for any personal injury illnesses, death or property damage occurring in connection with the use of the property or facilities of Martyn Meadows Ranch by me or my Associates.

With full knowledge, I, the Participant, release the Community Agriculture Alliance, Inc; the Steamboat Springs Chamber Resort Association, Inc; any sponsors and their respective officers, members, agents and employees for all actions, claims and demand of any kind and nature that may arise from or in connection with my participation in any aspect of the Cayuse Classic event accepting the risks involved.

MEDICAL – I, the Participant, consent to emergency medical care and transportation in order to obtain treatment for injury as the Martyn Meadows Ranch parties may deem appropriate. The above Release extends to any liability arising out of or in any way connected with the medical treatment and transportation provided in the event of an emergency.

SEVERABILITY - I, the Participant, expressly agree that the terms of release and indemnity contained herein are intended to be as broad and inclusive as is permitted by the laws of the State of Colorado. Any provisions or portion of this Release found to be invalid by the courts having jurisdiction shall be invalid only with respect to such provision or portion. The offending provision or portion shall be construed to the maximum extent possible to confer upon the parties the benefits intended thereby. The remaining provisions or portion hereof shall be construed and enforced to the same effect as if such offending provision or portion had not been contained herein.

As the undersigned parent or legal guardian of a person under 18 years of age, I hereby consent on behalf of such person and accept and assume all risks and all responsibility for any personal injury, death or property damage occurring in connection with the use of the property or facilities of Martyn Meadows Ranch by such person. On behalf of such person I release and indemnify the Martyn Meadows Ranch parties as stated above.
